# LCCI IQ ACCREDITATIONS AND RECOGNITIONS



British Council is a UK's international relations body. They work in partnership with the UK exam boards to help them promote their qualifications overseas.

CEF (Common European Framework of Reference for Languages) is a guideline used to describe achievements of learners of foreign languages across Europe and, increasingly, in other countries. It was put together by the Council of Europe as the main part of the project "Language Learning for European Citizenship" between 1989 and 1996. Its main aim is to provide a method of assessing and teaching which applies to all languages in Europe. In November 2001 a European Union Council Resolution recommended using the CEF to set up systems of validation of language ability. The six reference levels have become widely accepted as the European standard for grading an individual's language proficiency.

LCCI IQs are recognised by the British Council as well as aligned to the CEF and as such are internationally recognised.

UCAS (Universities & Colleges Admissions Service) is the organisation responsible for managing application to higher education courses in the UK. Every year, they process more than two million applications and help students to find the right course.

A majority of universities, both in the UK and overseas, accept EDI – LCCI IQs as satisfying the language requirements for candidates whose first language is not English. Accross Europe, LCCI English Language qualifications are recognised by universities and institutions of higher learning, including a large number of Universities in Italy, as credit bearing modules as part of the European Credit Transfer System (ECTS).

The alignment of LCCI IQs to the Common European Framework (CEF) enables their comparison across European centres with differing national education standards.



The UK Border Agency (UKBA) is the border control body of the United Kingdom government and part of the Home Office. In 2008, they introduced the Points Based System to manage migrants wanting to work and stuy in the UK. One of the requirements of The Points Based system is a competent standard of English that the migrant is expected to demonstrate.

Depending on the migrant category, the UK Border Agency recognises different levels of the following EDI – LCCI International Qualifications:

- EfB (English for Business)
- JETSET (Junior English Tests & Senior English Tests)
- ELSA (English Language Skills Assessment)
